ONLINE NORTH CAROLINA TAX RESOURCES

North Carolina State Archives has several digital collections that have laws, court cases, tax lists and other tax records. One collection is Tax Lists & Records from General Assembly, Treasurer & Comptrollers, and Secretary of State records. The archives digital collection can be found at archives.ncdcr.gov.

Another source of digitized tax records from many NC counties is DigitalNC. A basic search in Collections listed 8,282 results. Searches can be filtered by using Advance Search. Search tips are available.
